**Eligible Students:**

- Students must be aged 18 or younger who must have
  - no insurance and/or no insurance for vaccines OR
  - have/be eligible for Medical Assistance and/or Maryland Children's Health Insurance Program insurance (M-CHIP) OR
  - be of Alaskan or American Indian descent.
- NOTE: Students with private insurance will not be able to obtain vaccines at health department clinics and should be referred to their health care provider.
